

## LinkSquares Licenses

There are four licenses customers can purchase to use and administer the LinkSquares Cloud.

### IT System Admin

The IT System Admin license is for users that will solely focus on administering the applications. This license should only be applied to users that **DO NOT** need to perform functions within any applications in the LinkSquares Cloud.

### Power User

A Power User license is for users that need to be able to access applications in the CLM suite as well as manage settings and users. This includes creating custom roles in Analyze. **This is the highest level of license.**

### Standard User

A Standard User license is for users that operate often inside the applications but only need to be provided functions required to perform their daily tasks in the application.

### Lite User

A Lite User license is reserved for users that require very limited access in the application. These users may only need to draft agreements in Finalize.

## User Roles

For granular permissioning, there are multiple User Roles across the LinkSquares Cloud. Analyze users can be assigned one of three roles — Standard, Admin, or Manager. Finalize users can be assigned one of five roles — Drafter, Sign-Only, Reviewer, Approver, or Admin. Prioritize users can be assigned one of two roles — Member or Admin.
