



Ethics and Integrity



Intersection of ethics and integrity

- What is integrity in the first place?
- Difference between ethics and integrity
 - **Ethics:** Set of standards that helps us determine what's right or wrong in a given situation
 - Integrity is about consistency in actions, values, methods, and principles. It's about doing what's right, even when no one is watching
 - For a legal team, integrity means staying true to our ethical standards, even under pressure. It's about keeping our promises, being honest, and standing up for what we believe is right

Appendix

Rule 1.13: Organization as Client



Explanation

Attorney-Client relationship. A lawyer employed or retained by an organization represents the organization acting through its duly authorized constituents.



Rule 4.3 - Dealing with unrepresented persons

Explanation

In dealing on behalf of a client with a person who is not represented by counsel, a lawyer shall not state or imply that the lawyer is disinterested. When the lawyer knows or reasonably should know that the unrepresented person misunderstands the lawyer's role in the matter, the lawyer shall make reasonable efforts to correct the misunderstanding. The lawyer shall not give legal advice to an unrepresented person, other than the advice to secure counsel, if the lawyer knows or reasonably should know that the interests of such a person are or have a reasonable possibility of being in conflict with the interests of the client.



Rule 5.3: Responsibilities Regarding Nonlawyer Assistance

Explanation

a partner, and a lawyer who individually or together with other lawyers possesses comparable managerial authority in a law firm shall make reasonable efforts to ensure that the firm has in effect measures giving reasonable assurance that the person's conduct is compatible with the professional obligations of the lawyer;





Maintaining the Integrity of the Profession

Explanation: Rule 8.4: Misconduct

Lawyers can face disciplinary action if they violate or attempt to violate the Rules of Professional Conduct, or if they knowingly assist or induce another to do so. However, advising a client on legal actions they're entitled to take isn't prohibited.
